The system is fed by text files (Plans) generated from the Nomina and the bases of the S.U.A. and the I.M.S.S.

The S.I.A.S.S. system makes a connection with the S.U.A. of I.M.S.S. and allows us to make changes to Social Security Number; It purges information from previous years without eliminating employees from the system; eliminates movements charged to S.U., Consult charged affiliated movements, concentrates of C.O.P. etc., allows to determine the business cost by area of work, department or geographical area.
